




Aboriginal and Torres Strait Islander people

- 3,160 Aboriginal and Torres Strait Islander people currently serving (3.7% of all currently serving)
 - 76% male and 24% female
 - 75% in the Regular Service and 25% in the Reserves
- Previously served (2.3% of previously served)
 - 82% male and 18% female
 - 57% in the Regular Service, 33% in the Reserves, and 10% in both


- 9.8 million households (occupied private dwellings) on Census night








People aged 15-64, Equivalised weekly household income, by whether served in the ADF










Whether needed assistance by type of previous service and age group




Long-term health conditions – current service Census

- Current service members less likely to report LTHC than those with previous service and those who had never served.
- Of those aged 15-64:
 - Around one in five (22%) reported one or more LTHC
 - Younger members (15-44) less likely to report (16%) compared with 45-64 year-olds (38%)
 - Most common conditions reported: mental health conditions
 (7%), arthritis (6%), asthma (5%)











Proportion who had volunteered in the previous 12 months, by whether served in the ADF and sex

Some key insights include:


- Overall about 40% of total veterans reported in the census are DVA clients.
- 41% of male veterans and 36% of female veterans in the census are DVA clients.
- Queensland has the most veterans at 163,133, with 75,975 (47%) being DVA clients.
- Victoria has the lowest proportion of total veterans who are DVA clients with 33,929 of 105,225 (32%) veterans being DVA clients.
- Townsville is the region with the most currently-serving persons, and the most who have ever served. Approximately 66% of those in Townsville who have served are DVA clients.

More key insights include:

- 19 regions have more than 4,000 residents who have served. In these regions approximately 51% are DVA clients.
- 10 regions have more than 800 residents who have served with fewer than 25% being DVA clients.
- Boroondara in Victoria has 2,322 residents who have served, with 24% being DVA clients.
- Far North (Queensland) has 923 residents who have served, with 16% being DVA clients.
- In June 2021, DVA had 240,231 veterans as clients.


The total number of serving members and veterans identified in the census (581,139, noting a 96% response rate to the census) was very close to DVA's population model projection of 613,335, which includes 9,469 veterans from allied countries.

Current published stats

Pensioner summary statistics — VEA only

These reports summarise the major pension groups by rate of payment, state of residence, sex, age and conflict in which the veteran first served.

Treatment population statistics

These statistics report on the Department's treatment card population by eligibility, card type, state, sex, age and conflict in which the veteran first served. The treatment population consists of veterans and dependants entitled to treatment at departmental expense and who have been issued a DVA Gold or White card

Top-20 accepted conditions (recent conflicts & Vietnam)

These statistics report the top-20 accepted VEA and MRCA conditions as coded by the Statements of Principles for the following conflicts: Afghanistan, Iraq, East Timor (Timor Leste), Solomon Islands, Vietnam

Population projections (Executive Summary)

The Executive Summary of DVA Beneficiaries contains 10 yearly National and State/Territory forecasts for all pensions, card holders and miscellaneous benefits entitled under the VEA, MRCA & DRCA. These forecasts can be broken down further into age, gender and other categories upon making request to the DVA Data & Insights Branch.

DVA Stats at a Glance

The DVA Stats at a Glance card is a summary card produced twice a year which includes high-level information about DVA's clients, pension rates and Departmental expenditure.

Local Government Area (LGA) profile

These reports summarise the numbers of DVA pensioners and treatment card holders in each of Australia's local government areas by State and Territory.

Federal electorate profile

These profiles report on the number of DVA pensioners and treatment card holders in each of the Federal electorates by State and Territory.
